It was resolved to enter into a 3-year Long Term Agreement (LTA) with Came & Company at a total cost of £1,718.62 per annum. (Proposed by Cllr Wyer)
- To consider the internal audit interim report from the Council's Internal Auditor, Mr Stuart Pollard of Auditing Solutions, for the financial year 2016-2017 and agree any actions. A copy of the report had been issued with the agenda. The Assistant Clerk confirmed that the recommendations provided in the report had been addressed as follows:
 - 1. Long-standing cheque has been cleared from the accounting system.
 - 2. Step-by-step guide to the finances has been produced and is kept in the back of the red finances folders.
 - 3. Stamp has been purchased and is in use.

Further information had been issued with the agenda. It was resolved that there had been no litigation, liabilities or commitments, events or transactions, occurring either during the 2016-2017 financial year or afterwards, which would have a financial impact on the Town Council. Cllr Downes asked whether a proxy vote could be used if a Councillor is unable to attend the meeting at which the co-option is taking place. Members agreed that this would not be suitable as an accurate judgement cannot be made without seeing the presentations during the meeting. It was resolved to approve the Town Council's Co-option Policy. (Proposed by Cllr Harris)

To consider hosting and sponsoring a Moor Otter sculpture in Crediton for £500+VAT. Further information relating to this item had been issued with the agenda. The Assistant Clerk confirmed that Crediton Chamber of Commerce fully support the project and are willing to contribute £250 towards the cost. Crediton Town Team voted not to support the project due to their current commitments.

Cllr Sansom advised members that due to the popularity of the otter sculptures, she arranged for one to be reserved until after the meeting to avoid the Council missing out on the opportunity. As the only suitable location is Crediton Community Bookshop, Cllr Sansom chose Otter 054 'Otterly Alice' which is based on Alice in Wonderland. Members agreed this was a fitting choice. Cllr Sansom also confirmed that there will be 30,000 booklets produced showing all 100 otters, with a map containing directions to each location.

It was **resolved** to host and **sponsor** a **Moor** Otter sculpture for £500 + VAT, with the Town Council funding the additional £250 from the General Fund, and for the otter to be located in Crediton Community Bookshop. (Proposed by Cllr Harris)

Members thanked Cllr Sansom for the research and work she has put into this project.




