Community Briefing Note

Concerns regarding odour from Crediton Dairy

29 August 2019

This briefing note is issued by the Environment Agency in response to reports of odour from Crediton Dairy.

Crediton Dairy Limited hold an Environmental Permit which authorises the treating and processing of milk and the treatment of effluent at the site. The Environment Agency is responsible for assessing compliance with the Environmental Permit to ensure that the environment and local communities are protected.

Officers from the Environment Agency have visited Crediton and have identified odours offsite which are attributable to Crediton Dairy. The effluent treatment plant has been found to be one of the sources of the odour and Crediton Dairy Limited are investigating the reason for this.

Unfortunately we cannot provide feedback to all reports made. However when you call us, your report is formally logged and an anonymous copy of the report is passed to Crediton Dairy for them to act on.

Please continue to report any incidents of odour pollution to us. You can do this by calling our 24 hour Environmental Incident Hotline telephone number on 0800 80 70 60.

You can also contact the site directly to convey your concerns. Sean McMillan is the Environmental, Health and Safety Manager for Crediton Dairy and he can be contacted by email using <u>Sean.McMillan@creditondairy.co.uk</u>.
