# Quote 1

### Work:

• To put in a small 3m section of boardwalk and surface either side of this, to each gate with some road planings. I would estimate the equivalent of 3-man days.

#### Cost:

• Labour + some fixings: £650 - £700 pus vat (materials supplied by DCC FOC).

# Quote 2

# Work:

• Level the path with a mini digger and widen it on the narrow section with some of the mud that had been deposited by the river. I think this would be the longest lasting and safest option. The path would still be reasonably slippery when wet but wider and level. This section would require stoning up to make it not slippery.

# Cost:

- £350 +VAT.
- To install a handrail would be £450 plus VAT

There is some plastic material in the DCC depot that we could use if we wanted to make a plastic deck 3M long.
