To consider the following issues and agree a course of action – Vacant plots, Non-Cultivation
 Notices and Notices to Quit

 To consider matters raised by the Boniface Allotments Association and allotment tenants and agree any actions, including the following:

Following the Boniface Allotments Association AGM, Dr Tearle raised the follow points:

- Allotment holders would like to revisit the idea of water troughs at the allotment sites.
- The top path at Exhibition Road allotment site, adjacent to the road, is uneven and needs remedial works. It was agreed that this would be looked at as an annual requirement when renewing the grounds maintenance contract in 2023.
- For the committee to consider creating a parking space at the Exhibition Road allotment site where there is currently a flat, unused bit of earth. It would be used as a drop off spot and would benefit the accessible plots at the rear of the site.



It was **agreed** that a site visit would need to be carried out with Dr Tearle to look at the works to the path and parking space suggestion.

It was **agreed** that all points raised will be included as future agenda items.

110 To receive a report on the installation of a new dog waste bin at the junction of Downeshead Lane & Wellparks Hill and agree any actions.

It was **resolved** for a new sign to be produced to encourage dog-owners to dispose of dog foul and signpost them to the nearest bin. (Proposed by Cllr Harris) Members agreed that the installation of a new bin should be reconsidered once the new footpath is complete.

111 To receive the report on the floral arrangements and associated costs for 2023 and consider the recommendations therein

It was **resolved** to agree for Sustainable Crediton to take on the planting and maintenance of the Newcombes Meadow flower beds for 2023, with plans and costing provided by Cllr Ross as a guide. (Proposed by Cllr Harris)

It was **resolved** to recommend that the council budget for Option 2, with the possibility of volunteer help being explored. (Cllr Brookes-Hocking)
