#### 115. Public Question Time

A representative of the Boniface Allotments Association made a brief presentation on a proposal to reshape the entrance to the Barnfield allotment site to ease access. Members agreed to bring forward the agenda item on this topic to discuss whilst the Allotment Association representatives were present.

Councillor Adams entered the meeting.

#### **116.** Allotments (Brought Forward from agenda item 7.c)

Barnfield Entrance Proposal

Members considered the Allotment Association's preferred proposal for reshaping the entrance to the Barnfield Allotment site. It was agreed to defer a decision on this proposal pending an inspection of the site.

#### 117. Chairman's & Clerk's Announcements

The Council Chairman announced that he would be raising the issue of parking on pavements in the town with Council and it was noted that the District Council have devolved powers from the County Council to institute areas of no pavement parking within the District.

The Clerk briefly reported salient points arising from the District Council's meeting of Town and Parish Clerks.

#### 118. General Purposes Committee Minutes

The minutes of the General Purposes Committee meeting held on 2 March 2010 were received and approved as a correct record.

#### 119. Planning

a) Planning Decisions

Noted.

b) Planning Applications

Comments made in respect of planning applications considered at this meeting are appended.

Members noted that it was important that applications outside, but close to, the Town boundary continue to be considered in light of the District Council's Local Development Framework document and possible major, edge of town development.

c) Planning Applications/Items for Determination week ending 6 April 2010 None.

#### 120. Allotments

a) Clerk's Report

The Assistant Town Clerk updated members on the current situation with regard to plot vacancies and issues raised by the Allotment Association and tenants.

b) Reshaping Plot E28A and re-routing dividing path.

It was agreed not to formally approve the request to adjust the boundary of this plot.

c) Matters raised by Tenants

There were no matters raised by tenants, however, Councillor Adams informed members the water had been turned on after the Winter at the Barnfield site but that one of the taps on the Exhibition Road site leaked steadily so the water at this site had been left turned off. It was agreed that the tap would be blanked off whilst the Allotment Association considered whether they would prefer to repair the tap or have a trough with a float valve at which to fill watering cans. A decision on the nature of the repair was deferred pending input from the Boniface Allotment Association.

#### 121. Mid Devon District Council

a) MDDC/Parish Charter

The charter was received and noted. Concerns were raised that changes in policy and strategy were being presented to Council too late in the process of raising proposals. For example, one evening's exhibition of the proposed Local Development Framework was not sufficient and did not involve local people in contributing to possible solutions to local problems and issues. The item was referred to Town Council.

b) Website Data Protection Act Authorisation

The provision of the requested details to the District Council was approved.

c) Licensing Request, Cost-Cutter Store, High Street.

The Council had no objections to the Licence variation request in the interests of equal competition.

#### 122. Devon County Council - Highways

a) Exeter Road Proposed speed limit

Members approved the proposed extended 30 and 40 m.p.h. speed limits. It was also suggested that the 40 m.p.h. speed restriction could be extended further, just to the east of the Hookway Cross and A377 junction, to provide some protection for this junction on the brow of the hill. It was also noted that the Crediton to Newton-St-Cyrs section of the A377 is the only part of the route from Crediton to Exeter with an unrestricted, national speed limit

b) Waste Transfer Station.

The updated information on the temporary use of Punch Bowl Recycling Centre as a waste transfer station was received and noted.

#### c) Four Mills Lane Zoning

Members expressed their disappointment that neither "dual use" signage nor speed restrictions were considered by the Highway Authority for this narrow road with no footpath along it's length. It was agreed to defer this item to Town Council as neither the County nor the District Ward Members involved with this issue were present. In the interim, it was requested that the Clerk ascertain the nature of "major environmental impact" in para. 3 of the Highway Authority's response to the Council.

#### 123. Property

#### a) Dog Waste Bin

It was noted that there was already a dog waste bin on the signal box fence at the level crossing and, following inspection it was not considered necessary to place an additional bin at this location. It was requested that the Clerk inform Mr Fletcher of the decision.

#### Councillor Adams left the meeting

#### b) Fingerposts

Councillor Way entered the meeting during the debate on this item

The Clerk updated members on the ongoing negotiations with the District Council and local contractors on the costs of installation of individual finger signs and an additional finger sign-post. The following was agreed:

- Add the library to the Market Street, Union Street toilets and new Town Square posts.
- Add "Shopmobility" or "Community Transport" to the Market Street and new Town Square posts.
- The "Boniface Statue" sign could be moved from the Market Street post to the new one in the Square.
- In addition to the above, "Toilets", "Tourist Information" and "Shopmobility/Community Transport" should go on the new Town Square post.
- The proposed, new post should go on the North Western corner of the Town Square, the exact location being subject to talks with the District Council.

In addition it was suggested that consideration be given to providing signage to the Arts Centre, with at least one sign on the High Street. It was suggested that the "Toilets" sign at the Union Street toilets could be removed to make space for this and the "Boniface Statue" sign on being moved could leave space on the Market Street post. *Refer to Town Council*.

#### c) Teen Shelter

It was reported that the District Ward member investigating this issue had met with youth workers to establish the favoured location for the shelter, however, there was not yet a clear conclusion. Members expressed concern over the suggestion that the shelter was going to be installed in Newcombes Meadow, however, the Clerk reminded members that the Newcombes Meadow location was only one of several suggested locations and no decision had yet been taken. This item was deferred to a future agenda item.

#### 124. Queen's Diamond Jubilee

The Chairman suggested that an "events" Council Working Group should be established to be a central group to widen the membership of the body to include non-councillors to draw on the previous experiences of others in the town. It was emphasised that the town's schools need to be included as they will undoubtedly have their own ideas. Referred to Town Council.

#### 125. May Day Celebrations

It was reported that it was now too late to organise anything for this year, but that, hopefully, something could be arranged for next. It was also suggested that the proposed "events" Working Group, (see Minute 124.), could incorporate this issue within its remit.
