#### 5. Chairman's & Clerk's Announcements

The Council Chairman reported that his public appearance at the Farmers' Market in the Square was much more effective than the Mayor's Surgeries, especially now the Police Beat Manager was unable to attend on Mondays.

The Committee Clerk reported on leave and staffing arrangements for the week and that the Parish Lengthsman's last day in the town would be the following day.

#### 6. General Purposes Committee Minutes

The minutes of the General Purposes Committee meeting held on 11 May 2010 were received and approved as a correct record.

- d) Mid Devon Allocations and Infrastructure Development Plan (DPD) Examination
  The Allocations and Infrastructure Development Plan Document, Consultation on
  Matters Arising at the examination, was received and noted. Councillors remarked how
  clearly the amendments made had been marked. It was further agreed to invite a
  District Council Planning Officer to the next Town Council meeting to discuss the
  implications of the amendments in the consultation document. However, members reiterated the Council's previous recommendation that the Valley Bye-pass route should
  be retained as an integral part of the LDF and also that no further major development
  takes place on the Creedy Corner, Peddlar's Pool side of town until suitable
  infrastructure is in place, specifically, a decent link road to the Creedy corner area.

#### 8. Allotments

a) Clerk's Report

The Assistant Town Clerk reported on current vacancies and the condition of several plots.

b) Exhibition Road Taps Replacement.

The Clerk reported that the taps had been repaired or replaced as the second tap had failed. Members were informed that the invoice for the work had yet to be received.

c) The Boniface Allotment Association Minutes of 24 May 2010.

The Minutes of the Boniface Allotment Association meeting of 24 May 2010 were not available, however the Clerk had been briefed on issues arising from the meeting & updated the Committee members. Members agreed to fund the purchase of mulch for the recently planted trees at the Barnfield site.

d) Matters raised by Tenants and Boniface Allotment Association

The Allotment Association representative reported there were no significant issues beyond those already covered but they agreed to contact and liaise with the contractor altering the Barnfield entrance.

- b) The recommendations of the working group were approved as minuted. An initial budget of £150- was allocated to the removal of the tulips from the Town Square.

# 11.Mid Devon District Council - Draft Strategic Partnership, Sustainable Community Strategy Consultation Document

The Draft Strategic Partnership consultation document, "Sustainable Community Strategy" was received & noted. It was also noted that the document was being presented to the District Council's Executive on Thursday 10 June 2010. Members agreed that the section

on Public transport needed to include Market Towns, not just the rural areas, especially with ongoing edge of town developments left with poor or not useful bus scheduling. Members commended the District Council on the reduction of recyclable material now going into landfill and fully agreed with the District Council's aims in this area and the ongoing work that was reported to improve recycling rates in the district. It was however, reiterated that the local recycling centres at the supermarkets still accept a smaller range of recycling materials than other, similar sized supermarket sites in the area. It was also noted that cardboard, whilst being composted, was not actually being recycled and that the collection of plastic milk bottles was having an effect on the range of material collected. This item was requested as an agenda item for the Town Council with an officer invited from the District Council to attend.
