#### 131. Public Question Time

There were no public questions.

#### 132. Meeting Management

The Chairman announced that there would be an emergency item on the Buller Square fire and the Council's Crediton Support Fund. The item would take place after the item on planning.

#### 133. Pre-Application Consultation Presentation on Proposed Development at Trenavin

The representatives of the agent, Rymack Ltd, gave a brief presentation on a pre- application consultation for a proposed development at Trenavin, George Hill, Crediton. Brief details of the layout, number of dwellings, including affordable housing, as well as vehicle and pedestrian accesses were given to Councillors and the representatives answered questions from Council members and members of the public.

The Rymack Ltd representatives left the meeting.

#### 134. Chairman's & Clerk's Announcements

The Assistant Town Clerk reported the staffing situation and workload in the Town Clerk's Office and therefore the delay in the completion of some routine tasks.

## 135. General Purposes Committee Minutes

The minutes of the General Purposes Committee meeting held on 8 November 2011 were received and approved as a correct record.

## 136. Matters Arising

- *Minute 112:* Councillor Way updated members on progress with the installation of new grit and salt bins in the town by the Highways Authority.
- *Minute 113:* Councillor Brookes-Hocking reported that the Policy and Forward Planning Working Group had now met.
- *Minute 115:* At the request of Councillor Conyngham, the Assistant Town Clerk updated members on progress with this item.
- *Minute 123.* At the request of Councillor Dixon, the Assistant Town Clerk confirmed that no further communications had been received from the Parish Church.

# 137. Allotments

- a) The Clerk updated members on current issues, vacancies and the present state of the waiting list. In addition major points and issues raised by the Allotment Association at their committee meeting of 25 January 2012 were reported to members.
- b) There were no additional issues raised by the Allotment Association beyond those briefed by the Clerk.
- c) There were no allotment tenants present.

The Boniface Allotments Association Representative left the meeting.

#### 138. Planning

a) To consider issues arising from the pre-application consultation on the proposed development at Trenavin by Rymack Ltd.

A member of the public made a representation to inform Councillors that they believed the District Authority's maximum recommended housing density for this site was 25 units, even if the theoretical maximum possible density greater. It was also pointed out that the development may well seriously impact the tree density on the site.

After consideration, members emphasised the following:

- 1. The development will affect the character of the area of the town.
- 2. The development will affect the green infrastructure of the area of the town.
- 3. The buildings should be of two storey construction only with no loft development.
- 4. The impact on the local road infrastructure and traffic must be seriously considered.
- 5. A second pedestrian and cycle access should be provided from the stub road or turning bay in the South West corner of the development through to George Hill.

Additionally, it was agreed to request that the District Council confirm the following:

- 1. The housing density provided for when last assessed for the Local Plan.
- 2. That the District Council and Highways Authority have been consulted on the effects of the development on traffic and transport infrastructure.
- 3. The Air Pollution Officer had been consulted on the impacts of the development.
- 4. A Planning Officer to visit the Town Council once the application has been submitted.
- 5. A suitably long consultation period be allowed to respond to the application, to permit the consideration of the application against the Town Council's Town Plan.

#### 139. Crediton Support Fund for Those Residents Made Homeless by The Buller Square Fire

To Assistant Town Clerk gave a brief update on the size of the fund, arrangements made for accounting for and banking monies, including the valuable assistance of the District Council's Local Area Office in handling the cash and measures taken to provide an acceptable audit trail. The actions taken to manage other offers of help in the form of practical assistance and lists of items for donation were also reported. The County Council Ward Member also updated the Committee

## 140. Finance

- a) The Schedule of Accounts, Cheque numbers 3400 to 3408 totalling £6,837.22, was approved.
- b) Members were unable to consider the donation request from the Crediton Food Festival as councillors had not received the papers. This was deferred to the next Town Council.

### 141. Parish Paths Partnership Sub-Committee Meeting Minutes

- a) The notes of the Parish Paths Partnership Sub-Committee meeting held on 21 December 2011 were received and noted.
- b) The recommendations of the Parish Paths Partnership Sub-Committee, as previously considered by the Finance Committee, were approved.

#### 142. Peoples Park and Scout Memorial Gardens Working Group Minutes

- a) The notes of the Peoples Park and Scout Memorial Gardens Working Group meeting held on 31 January 2012 were unavailable due to the events of the incident in Buller Square and subsequent calls upon the Clerk's Office resources.
- b) This item was deferred to the next Town Council meeting.

## 143. Peoples Park and Scout Memorial Gardens Signage

The Committee considered reports of skateboarders and cyclists using the Scout Memorial Gardens as a sports and skate park and measures to deter such use were debated. It was agreed that signage forbidding skateboarding and other "extreme" style sports needed to erected at the Memorial Garden and that the cost, wording, location and actual erection needed to be investigated.

#### 144. Mid Devon District Council – Economic Strategy Documentation

The Committee received and considered the District Council's Economic Strategy Document. Some concerns about the document were aired, however it was felt that there had not been sufficient time allowed for thorough consideration of the document to be made. It was therefore agreed to defer the item to the next Town Council and request the District Council extend the response deadline accordingly.

#### 145. Broadband Issues (documents distributed separately)

- a) The request from the Connecting Devon and Somerset Broadband Programme for community engagement and support was received and considered. It was agreed that the Town Council support the campaign.
- b) The press release from BT concerning broadband improvements in Devon was received and noted.

#### 146. Action for Market Town Awards 2012

The merits and drawbacks of entering the Action for Market Towns annual awards 2012 were considered. It was agreed that it would take some effort to complete an award bid in time. Councillor Leighton Plom stated that he would be prepared produce an entry but would need help from another Councillor. It was agreed that all Councillors would be asked to consider if they could help Councillor Leighton Plom.

#### 147. Town Council Newsletter and Communications

Councillor Szabo updated members on progress he had made investigating greater distribution of the Council's quarterly newsletter. Members agreed that Councillor Szabo continue his investigations into distribution and display options to enhance the visibility of the newsletter.

#### 148. Crediton Cemetery and Recycling Item requested by Councillor Conyngham

Councillor Conyngham had noted the amount of compostable waste that was being disposed of via rubbish bins in the cemetery and wondered whether it was not possible for the District Council to install a compost bin next to each waste bin to avoid this material being sent to landfill. It was agreed that Councillor Conyngham should contact the District Council's Open Spaces & Cemeteries Manger to progress this.

#### 149. Register of Publicly Owned Property and Assets in the Town Item requested by Councillor Dixon

The Committee considered a motion placed before members by Councillor Dixon: "Since the enactment of the Localism Bill is nearing completion this issue is becoming urgent. It is therefore moved that a letter, signed by the Clerk, to the be sent by Royal Mail to the Chief Executives of each local authority requesting the Town Council be provided with a list of their publicly owned assets in the form of buildings and land that each authority respectively owned, with a request for an urgent reply to be included." After consideration the motion was approved. It was briefly considered that this be made a freedom of information request, however, it was felt it better to

give the local authorities the opportunity of responding before resorting of the Freedom of Information Act.
