171 To receive and accept apologies

172 Declarations of Interest

Cllr Brookes-Hocking declared a personal interest in planning application numbered 14/00541/FULL.

173 Public Question Time

Mr Bowsher, a local resident has written two books of poems. He recently took part in a Crediton Courier competition to write a poem about the town/place where you live. 175 Chairman's and Clerk's Announcements

Cllr Letch advised members that last week he and Cllr Brookes-Hocking and the Town Clerk had attended the South West Conference of Local Council Associations where several informative workshops were held covering Finance, Pensions, The Sustainable Communities Act and the new Quality Council scheme.

The Town Clerk advised that as well as the conference, she had also attended finance training last week, which had been extremely informative and she would be making suggestions for improvements to the council's internal control procedures at the next meeting of the Finance & General Purposes Committee.

a) To receive notification of decisions made by the Planning Authority. It was resolved to note the decisions of Mid Devon District Council, the determining Authority, with conditions as filed, which are attached as Appendix One.

b) To consider planning applications.

Cllr Brookes-Hocking declared a personal interest in planning application numbered 14/00541/FULL. It was **resolved** to make comments in respect of planning applications considered at this meeting, which are attached as Appendix Two.

- Accounts Due for Payment and Receipts To examine and agree the accounts due for payment and receipts for the period 2nd April 2014 to 6th May 2014 inclusive and to receive the bank reconciliation. The Clerk circulated the payments and receipts list and the bank reconciliation. She pointed out that for clarity the payments and receipts list covered everything from the 1st April 2014 as it was the beginning of the financial year, this meant that payment vouchers numbered one to five inclusive had been approved and paid at the previous meeting. It was resolved, with no votes to the contrary, to approve the payments totalling £25,204.12 and receipts totalling £70,527.04 and to accept the bank reconciliation, copies of which are attached to these minutes as Appendix Three. 182 To receive a report from the Council's internal control checkers, following a monthly random inspection and agree any actions.

183 To consider the internal audit report from the Council's Internal Auditor, Mr Ken Abraham, for the financial year 2013-2014 and agree any action.

A copy of the Annual Return had been issued with the agenda. It was **resolved** to agree the Annual External Audit return for the financial year 2013-2014 and recommend it to full Council. (Proposed by Cllr Letch seconded by Cllr Wyer)

186 To Discuss and Agree the Annual Governance Statement Detailed in the Audit Commission's Annual Return

A copy of the Annual Return's Governance Statement had been issued with the agenda. The questions in the annual governance statement were considered and answered. It was **resolved** to agree the Annual Governance Statement detailed in the Annual External Audit Return and recommend it to full Council. (Proposed by Cllr Letch seconded by Cllr Szabo)

To review the Council's insurance requirements and consider quotations received from insurance providers for insurance cover for the next three years.

Details of the quotations received were circulated by the Clerk including a comparison table detailing the level of cover provided. The Council's insurance requirements were discussed and the three quotations received were considered. It was **resolved** to accept a 3 year long term agreement. (Proposed by Cllr Brookes-Hocking, seconded by Cllr Letch) It was further **resolved** to recommend to Council that the quotation from Zurich be accepted. (Proposed by Cllr Brookes-Hocking seconded by Cllr Letch)

188 To receive confirmation of the Local Government Pension Scheme Contribution Rates for the period 2014/15 – 2016/17

The confirmation letter had been issued with the agenda. The Clerk explained that the employers contribution rate had been increased by 1% from 19.5% to 20.5%. It was **resolved** to accept the local government pension scheme employer contribution rates for the period 2014/15 – 2016/17(Proposed by Cllr Wyer seconded by Cllr Szabo)

189 Business brought forward

Cllr Letch:

 Advised that a patch of soil, which becomes unsightly with overgrown grass and weeds, had been left at the top of Butt Parks Hill following the removal of a telephone box. It has been suggested that this would be the ideal location for a grit/salt bin.

Cllr Szabo:

Had attended the launch of the Holy Cross roof appeal, which is the largest campaign
they have ever undertaken and the largest in the diocese. The initial estimate is that the
work will cost at least half million and the fundraising will continue for the next couple of
years.

CIIr Vincent:

Noted the changes in the bus numbers and frequencies.

Cllr Adams:

• Advised Holy Cross Church belongs to the people of Crediton, which is unusual.

Cllr Brookes-Hocking:

- Suggested that the Council's Grants Policy will need to be reviewed before the next scheduled Grants Committee meeting in November.
- Crediton Town's Neighbourhood Plan area designation is being considered by Mid Devon District Councils Cabinet Committee tomorrow.
