211. Town Council Minutes

The minutes of the Town Council Meeting held on 22 January 2008 were approved and signed as a correct record.

212. Matters Arising

Minute 181: a member reminded the Council that the new staff announced by PCSO Pilling at Crediton Police Station are not an increase in staffing levels, but a return to the previous numbers.

Minute 181e: It was reported that the information requested from the developers representative was on its way to the Council. It was also noted that Members were not in favour of development at Chapel Downs as reported in the press, merely identifying this as another option.

Minute 194: Councillor Brookes-Hocking reported on the offer of Local Authority Publishing of 6 years of guides, updated bi-annually, of 3,000 copies each, but with an additional 500 copies for the Crediton 2009 Festival. Councillor Nation asked for his thanks to Councillor Brookes-Hocking be recorded.

213. General Purposes Committee Minutes

- a) The minutes of the General Purposes Committee meeting held on 05 February 2008 were received and noted.
- b) The recommendations of the General Purposes Committee held on 05 February 2008 were approved.

214. Matters Arising

Minute 70(7): Councillor Nation reported that he had attended the Devon NHS PCT meeting, although there was little concrete information on the results of the strategic review.

d) MDDC Consultation on draft Supplementary Planning Document; Public Open Space Funding.

The draft consultation document was received and noted.

216. Finance

a) Schedule of Accounts

The schedule of accounts, numbers 002764 to 002770 amounting to £3,812.23 was approved.

It was reported that the contractor had been instructed to take greater care to minimise weed killer damage in People's Park, as noted by Councillor Nation previously.

b) Donation Requests

None.

217. Allotments

- a) The Assistant Clerk reported that there were currently 2 allotments vacant, both of which should be re-let shortly.
- b) Further delay was reported on the plot numbering project whilst awaiting delivery of the posts. As at the time of the meeting, they had not arrived at Tucker's.

- Councillor Way entered.
- c) The e-mail from the Boniface Allotments Association was noted. Members expressed concern at the issues raised and the disquiet obviously felt by the Association. It was also noted that Association volunteers would no longer be able to help with the post numbering work. Members agreed to write, under the Mayor's signature, to the Association to assure them of the value the Council places upon them and empathising with their predicament over the issues raised by them.

218. Town Council Representatives' Reports

- a) Council Representatives' Reports:
 - Councillor Letch reported on the BTCV work on the steps of Footpath 29, St Saviours Way up to QECC Lower School, and remarked on the good job they did.
 - It was reported in response to a Member's enquiry, that resurfacing Footpath 1, St Saviours Way to Landscore, is the priority project for the next financial year.
 - Councillor Wright reported on the events of the Crediton Climate Action Group Open Day.
 - Members were informed that the Fairtrade Café Crawl will be taking place on Saturday 23 February 2008 as part of the Crediton Fairtrade Fortnight.
- b) The Minutes of the Police Liaison Meeting of 06 February 2008 was received and noted. Members were informed that Sergeant Twigg will be discussing the issues associated with young drivers at the next Chamber of Commerce and Community Safety Group meetings.
 - Councillor Brown expressed concern over the issue of speeding on Jockey Hill, especially in the vicinity of the pedestrian access to the bungalows at the top on the East side. Councillor Brown requested a future agenda item.
- c) The Minutes of the Crediton CCTV Group Meeting of 15 January 2008 was received and noted. It was reported that the Chair of the Group was seeking sources of funding for expanding the system. It was emphasised that the CCTV Group was an advisory body and must defer to the final decisions of the Town Council.

SPECIFIC AGENDA ITEMS

219. Committee Membership

- a) The review of appointments to Council Committees and Sub-Committees was deferred due to the absence of the new Councillor, Councillor Hughes. It was agreed, however, to invite Councillor Hughes to join the General Purposes Committee.
- b) Members considered the requirement to create a Floral Crediton Working Group. It was agreed to set up the group consisting Councillors Harris, Letch and Brookes-Hocking. An initial meeting date of Monday 25 February 2008 was agreed to lay out skeleton planning and budgeting before advertising for public engagement. It was emphasised that other local organisations, such as the Allotment Association and the Chamber of Commerce, should be involved.
- c) Members considered the desirability of creating a Town Plan Working Group. It was agreed to set up the Group consisting of Councillors Brookes-Hocking and Nation and invite Councillor Downes to join.
- d) The resignation of Councillor Downes as the Council's Twinning Association representative was noted. The Assistant Clerk believed Councillor Hughes was prepared to accept this responsibility and members agreed to invite Councillor Hughes to represent the Council on the Twinning Association.
- **220. Market Street Traffic Management** (item requested by Councillor Downes)

This item was deferred due to the absence of the requesting member.

221. High Street Trees (item requested by Councillor Downes)

This item was deferred due to the absence of the requesting member.

222. Lords Meadow Leisure Centre

A Ward Member updated members on the outline of the two extant bids to run the leisure Centre, namely DC Leisure Management and Sports and Leisure Management, (SLM),

Ltd as well as the bidders event. It was also explained to the Council how the evaluation decision process would work and concern was expressed, especially by Ward Members, over the lack of input allowed from District Councillors by this process.

223. MDDC Review of Grants (item requested by Councillor Way)

Councillors Brown and Wright declared Prejudicial interest and left the meeting for the duration of this item.

Councillor Way updated members on the result of MDDC grant awards for the forthcoming year with respect of the grant to the Crediton Area Community Transport Group. Concern was expressed over the very different grant allocations and partnering arrangements between Tiverton and Crediton despite the symmetry of their applications. Councillors were concerned that the one year funding package and lack of strategic partnership would negatively impact the groups ability to raise funds with a possible perception of unreliability or funding weakness. It was understood that no reasons had been given for the differentials and members therefore agreed to write to MDDC asking for an explanation and also to request strategic partnership with the District Council in a similar vein to Tiverton.

Councillor Nation informed members that the issue will be referred to a working group of the MDDC Scrutiny Committee, although the Committee had no more information concerning the award of grants than the Town Council at present.

224. Litter Bins

Councillor Adams declared a Prejudicial Interest and left the meeting for the duration of this item.

Councillor Wright updated members on the project to install sponsored letter bins in People's Park and at Upper Deck. It was noted that one sponsor had pulled out and that the Council would have to fund the fifth bin from the Street Furniture Allocation. The Council is also paying for the sponsorship signs on the bins. The member tabled the designs and indicated the planned locations of the bins to which there were no objections.

Councillor Adams re-entered the meeting.

Councillor Wright additionally reported that a landscaper had met himself and the Town Clerk and was going to provide an initial proposal for renovating the Scout Memorial Gardens. A future agenda item was therefore requested.
