Minutes of Crediton Town Council Meeting, held on Tuesday, 21st January 2014, at 7pm, at the Council Chamber, Market Street, Crediton

1401/190 To receive and accept apologies

Apologies were received and accepted from Cllrs P Vincent, R Adams and W Dixon. (Proposed by Cllr Harris, seconded by Cllr Letch) Cllr N Way had sent apologies that he would be late; Cllr Brookes-Hocking apologised as she would need to leave early.

1401/191 Declarations of Interest

Cllr Downes as a member of more than one authority declared that any views or opinions expressed at this meeting would be provisional and would not prejudice any views expressed at a meeting of another authority.

Cllr Hughes declared a personal interest in agenda item 10 'Planning' minute number 1401/199 regarding planning applications numbered 13/01712/FULL and 13/01713/LBC as a member of, and fundraiser for, Crediton Congregational Church.

To receive a presentation from Mr Tim Baker FRICS, on the development of land NGR 284242 99827 (Wellparks) Exeter Road, Crediton

Cllr Letch welcomed Mr Tim Baker, representing Waddeton Park Limited, which has a promotion agreement with the Downes Estate, who own the land. Waddeton Park Limited is charged by Downes Estate with responsibility of promoting the land through the planning system. Mr Baker was accompanied by Mr George Dundon, Associate Partner of LDA Design who are the master planners.

Mr Baker and Mr Dundon proceeded to give a presentation to Councillors in relation to the site. (A copy of this presentation will be forwarded to the Town Clerk for circulation to members.) This included the surveys that have been carried out and/or commissioned; the site characteristics and constraints; visibility of the site from different areas in the town; vehicular access; possible development layout incorporating a potential 185 houses, which would contain a significant proportion (35%) of affordable housing.

At the end of the presentation Mr Baker explained to Councillors that they would like to run an exhibition in Crediton in the future, in order to consult the public on the proposals.

Councillors then had the opportunity to ask questions.

Copies of the application together with supporting documentation had been issued with the agenda

Cllr Downes declared a disclosable pecuniary interest as an employee of the Arts Centre and left the room.

It was **resolved** to support Crediton Arts Centre in their TAP Fund application for £2000 for the Crediton flag project. (Proposed by Cllr Harris, seconded by Cllr Wyer)

Cllr Way arrived at 8.02 pm and declared that as a member of more than one authority any views or opinions expressed at this meeting would be provisional and would not prejudice any views expressed at a meeting of another authority.

Cllr Downes returned to the room.

1401/203 To consider a request from Cllr Hughes to be appointed as a member of Crediton Town Council's Finance & General Purposes Committee.

It was **resolved** to appoint Cllr Hughes as a member of the Town Council's Finance & General Purposes Committee (Proposed by Cllr Harris, seconded by Cllr Letch)

1401/204 To appoint a Council representative to serve on the Newcombes Meadow Community Group.

It was **resolved** to appoint Cllr Wyer as the Council's representative to serve on the Newcombes Meadow Community Group. (Proposed by Cllr Letch, seconded by Cllr Downes)

1401/205 To consider whether the Council formally recognises the Crediton Chamber of Commerce.

This item has been requested by Cllr Vincent. Cllr Vincent was not present. The Clerk read a letter received via e-mail that evening from Mr Coryton, Co-Chairman of Crediton Chamber of Commerce. It was **resolved** to reply to Mr Coryton's letter acknowledging receipt and confirming the contents had been noted. (Proposed by Cllr Harris, seconded by Cllr Letch)

1401/206 To consider asking Mid Devon District Council to provide a complete recycling centre, including plastics, in Crediton, similar to the centre in Tedburn St Mary.

This item had been requested by Cllr Szabo. Cllr Letch advised that this is one of the questions he would be putting to Mel Stride MP at the meeting in March. Cllr Szabo gave a brief overview of the facility in Tedburn St Mary, although he did not know who provided it. Cllr Downes explained that Mid Devon District Council is currently reviewing waste collection and recycling services and there could be changes to the service provided in the future. He added that Mid Devon District Council was facing further funding cuts and one of the biggest spends in Mid Devon is waste and recycling.

To consider reminding Devon County Council of the Town Council's aspiration of installing a footpath on the west side of Mill Street in light of the Mole Avon development proposal.

This item has been requested by Cllr Way. It was **resolved** to write to Devon County Council reminding them of this aspiration and to write to Mid Devon District Council, as the Planning Authority, requesting that the provision of a pavement should be a condition of any development at the Mole Avon and ATS sites. (Proposed by Cllr Way, seconded by Cllr Downes)

1401/208 To receive updates on the following issues:

- Belle Parade cycle route
- Dropped kerb at Exeter Road

This item had been requested by Cllr Downes.

Belle Parade cycle route – neither the Clerk nor Cllr Way had received an update since December 2013, when it was understood the legal paperwork was being dealt with. Cllr Way advised that as soon as he received an update he would circulate it to all members.

Dropped kerb at Exeter Road – Councillors discussed the most recent letter received from Devon County Council stating nothing could be done, and found this response to be unacceptable. Cllr Way confirmed the issue will be discussed by Devon County Council's Highways and Traffic Orders Committee (HATOC) in March 2014. It was **resolved** to write to Devon County Council, with a copy being sent to County Councillor Way, stating that as a bare minimum a dropped kerb should be installed. (Proposed by Cllr Downes, seconded by Cllr Way)

1401/209 To consider and comment on Devon County Council's proposed budget reductions, which may make a difference to public transport and concessionary bus travel in Devon in 2014-2015.

It was **resolved** to accept that there had to be cuts. (Proposed by Cllr Harris, seconded by Cllr Ford. Cllr Way abstained.)

To consider a letter received from The Crediton Archive offering to photograph the Council, Councillors and employees as means of showing what the Council does and agree a course of action.

A copy of the letter had been issued with the agenda. It was **resolved** to thank Crediton Archive for its kind offer, however, the Council does not wish to accept it at the current time. (Proposed by Cllr Letch, seconded by Cllr Harris)

To receive recommendations/nominations for individuals who will receive a Crediton Town plate at the Mayor's Reception 2014.

Cllr Letch reminded Councillors that this is to recognise the efforts of those who demonstrate outstanding commitment to the well-being of Crediton and the community. He asked Councillors to submit nominations to the Town Clerk with the reason for the submission. All submissions would be considered at the February Council meeting in Part Two.

1401/212 Councillor Reports

Cllr Wyer reported:

• He had attended a meeting of the Newcombes Meadow Community Group on the 20th January, which had also been attended by Mr Steve Densham, Development Services Manager, Mid Devon District Council. Mr Densham had advised that as well as the Section 106 money that had been earmarked by District Councillors for the project, he was able to commit £50,000 to the playground refurbishment/regeneration. It is hoped that the project will be completed by summer 2014.

Cllr Downes reported:

• He was concerned to read a letter in the last edition of the Crediton Courier regarding planting in Newcombes Meadow and had sought clarification from Mid Devon District Council Officers. He advised there are no plans to make any changes to the beds around or near St Boniface statue. There will be no spring bedding in the park, this has been the case for at least the last three years and has been done along with other areas in the district as part of cost saving. The rose bed in the park near the library was levelled and grassed because the roses were very old and past their sell-by date. The decision was made as part of cost saving, not just the cost of the roses but for the future maintenance. The rose beds at the entrance of Belle Parade are staying and all planting carried out by the service around the district will stay as it is for now. A letter detailing all this will be sent by Cllr Downes to the Crediton Courier.
