## Minutes of Crediton Town Council Meeting, held on Tuesday, 23<sup>rd</sup> September 2014, at 7pm, at the Council Chamber, Market Street, Crediton

1409/96 Public Question Time

There were no questions.

1409/97 Order of Business

To receive a presentation/report from Dr Joe Mayes regarding the future of community services in Crediton, including Crediton Hospital.

Cllr Letch expressed that he would like to sincerely thank the Crediton Courier for the article written by Dr Joe Mayes on 5<sup>th</sup> September. Cllr Letch found the article enlightening and very useful along with the response published on 12<sup>th</sup> September that he said helped councillors and the population.

Cllr Way arrived at 7.02 pm and declared as a member of more than one authority, that any views or opinions expressed at this meeting would be provisional and would not prejudice any views expressed at a meeting of another authority.

Cllr Ford arrived at 7.04 pm

Dr Joe Mayes provided a report regarding transforming community services in Crediton and Crediton Hospital with the main points including:

- The aim to squeeze efficiency out of the system to ensure sustainability
- The importance for services to take place in a joined-up way
- The importance of people working as much as possible for the same organisation towards the same goal
- The difficulties involved in staffing small units along with the geography means it is unlikely that a case can be provided for providing patient care in Crediton
- Those involved understand concerns of patients and public and can ensure future care will be safe
- The aim to use Crediton Hospital in a more sustainable, effective and better way
- Potential to use Crediton Hospital as a health and social care hub providing a medical presence within the hub on a regular basis
- Crediton Hospital is the base for many teams thus already operates in a hub-like manner
- Increasing the presence of both the charitable sector and the private sector

• Views are welcomed regarding the use of the hospital site

Cllr Adams arrived at 7.07 pm

Member of public arrived at 7.09 pm

Members were then invited to ask questions.

Cllr Ford suggested the provision of a walk-in centre. Dr Joe Mayes expressed it would be unlikely for Crediton to adopt a walk-in centre service. Cllr Ford asked whether the closure of Crediton Hospital beds would overload Exeter services. Dr Mayes explained that the short answer is yes, however they hope not to have a large impact on beds in Exeter.

Cllr Way expressed that there is a campaign to keep in-bed services as that is the general consensus within the community. Dr Mayes explained that services and needs have changed since 1988 when the hospital was built when long term residential care was provided within the hospitals as opposed to that service now being provided through nursing homes. Dr Mayes also explained that the petition will be formally presented at the board meeting to be held on 24<sup>th</sup> September 2014.

Cllr Letch picked up on the lack of nursing homes in Crediton, with the nearest being Langford Park.

Cllr Szabo expressed how many organisations such as St Johns Ambulance and RNLI survive with no funding from central government. Cllr Szabo suggested benchmarking with such organisations to find out how they generate income. Dr Mayes pointed out that these organisations use volunteers and they are interested in capitalising on such an approach and this is the reason behind wanting to increase the presence of the voluntary sector.

Cllr Ford expressed her concerns regarding new housing developments in Crediton and the possible increase in demand for Crediton Hospital services. Dr Mayes explained that they have acknowledged the developments however do not expect these developments to largely affect the demand for Crediton Hospital services.

Dr Mayes advised members of a Public Meeting taking place on Wednesday 1<sup>st</sup> October, from 6 pm to 8 pm, in the Boniface Centre in which everyone is welcome.
