- Accounts Due for Payment and Receipts To examine and agree the accounts due for payment, receipts, and bank transfers for the period 11th December 2019 to 21st

 January 2020 inclusive and to receive the bank reconciliation. The schedule of payments and receipts had been issued prior to the meeting. It was resolved to approve the payments totalling £29,486.04, receipts totalling £1,063.18, and accept the bank reconciliation, copies of which are attached to these minutes as Appendix One. (Proposed by Cllr Letch)
- To consider and agree/amend Crediton Town Council's budgets prepared by the Council's Responsible Financial Officer for the financial year 2020-2021. Copies of the draft budget had been issued at the December meeting. It was resolved to agree the Town Council's budgets for the financial year 2020-2021, with a total budgeted expenditure of £275,165 and a total budgeted income of £25,604 excluding precept, a copy of which is attached to these minutes as Appendix Two. (Proposed by Cllr Brookes-Hocking)
- 2001/156 To consider and agree/amend Crediton Town Council's reserve levels for the financial year 2020-2021. Copies of the reserve level had been issued at the December meeting. It was resolved to:
 - Set the Council's general revenue reserve level at £75,000 for the financial year
 2020 2021
 - Agree the Town Council's earmarked reserve levels for the financial year 2020 -2021, a copy of which is attached to these minutes as Appendix Three, subject to any further spending on specific projects in this financial year. (Proposed by Cllr Brookes-Hocking)
- 2001/157 To discuss and agree Crediton Town Council's precept for the financial year 2020-2021.

The precept figures had been issued at the December meeting. Cllr Downes expressed concern that we have a bleak future ahead, with a recent budget meeting at Mid Devon District Council implying that service cuts are imminent. Based on this, Cllr Downes proposed increasing the precept to ensure sufficient funds are available should services be cut.

Members discussed this information as well as the Town Council's intended purchase of the Old Landscore School building and agreed that additional funding would be required to restore the building if it is purchased.

The Assistant Clerk explained that the precept is set by the budget figures and advised members that the Town Council has a general fund which is available to use when situations arise that the Council has not been able to predict and budget for. She also advised Councillors of the budget and reserves that have been allocated for the Old Landscore School building.

It was **resolved** to increase the precept by 5%, to £261,918.47, as members agreed that the funds allocated for the Old Landscore School building may not be sufficient and therefore an increase in the precept would help ensure sufficient funds are available to restore the Old Landscore School building as a public amenity. (Proposed by Cllr Vincent)

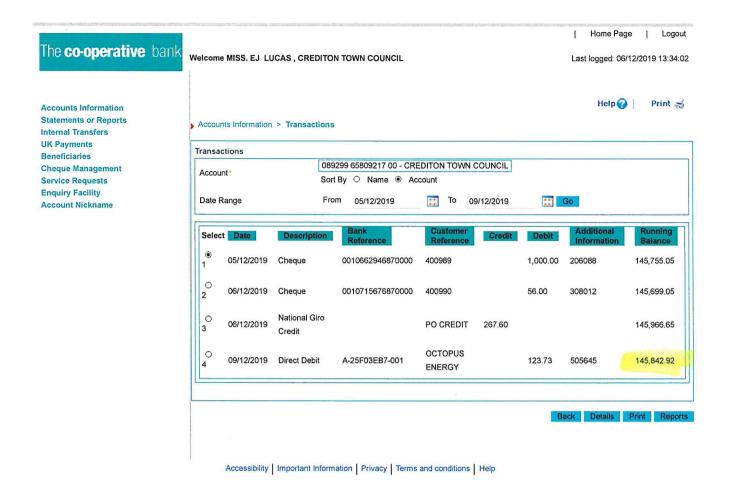
