It was resolved to adopt the new Grant Aid Application Form with the following amendments:

It was further resolved for the grant advertisement to be published:

- In the Council's notice boards
- On the Council's website, Twitter page and Facebook pages
- In local shops/facilities including Crediton Library and Co-op
- Members also agreed for letters to be sent to all recipients of a 2015-16 grant, informing them of the deadline for 2016-2017 grant applications.

12. To consider applications for grant funding for the financial year 2015-2016 from the following groups/organisations: Copies of the applications and supporting documents had been issued with the agenda. The Assistant advised members that the remaining grant budget for the financial year 2015-16 stands at £555.

The following grant applications were considered:

- Age Concern Crediton & District. It was resolved to recommend for this application to be brought to a full Council meeting in order to consider granting £1,000 from the General Fund. (Proposed by ClIr Brookes-Hocking)
- Crediton Congregational Church. It was **resolved** to approve a grant of £250. (Proposed by Cllr Brookes-Hocking)
- Unite Carers in Mid Devon. It was resolved to approve a grant of £305. (Proposed by Cllr Brookes-Hocking)

Cllr Brookes-Hocking noted that there is now no money available in the 2015-16 grants budget for any further applications the Council may receive and that the Council as a whole needs to be made aware that further project requests may come in before April 2016.
