Devon Air Ambulance Trust has confirmed that it will provide a grant of £5,327.91 and a TAP Fund application for £1,000 has been submitted by the Clerk on the Town Council's behalf. The Clerk also advised that should the QE Education Foundation decide to sell the land in the future, the Foundation would require the lighting column to be removed, however, Devon Air Ambulance Trust has confirmed it could be relocated elsewhere in the Town.

It was **resolved** as follows:

- For the Council to take on the ownership and maintenance of the lighting column as a community asset.
- To fund the remainder of the supply and installation of the lighting column with the money being taken from the Council's general fund. This will be £3,832.29, possibly reducing to £2,832.29 if the TAP fund application is approved.
- To submit and pay for a planning application for the installation of the lighting column.





- For the Town Clerk to liaise with the Trustees of the QE Education Foundation and Crediton Rugby Club, who lease the land, for the necessary permissions for the siting of the lighting column.
- For the Town Council's Solicitor to draw up a legal agreement between the Town Council, the QE Education Foundation and Crediton Rugby Club.
- The Town Council to actively promote the project, asking local groups and organisations to raise funds to contribute to this invaluable community asset, in order to offset the costs incurred.

The Clerk confirmed Cosmic had been contacted for advice to establish whether this could be done without allowing any access to the council's systems and files. Cosmic had advised it could be done but not with the free BT router the Council





currently has. It would need to be replaced with a VLAN device that can provide separate Wi-Fi, which is completely separate from the Council's (generally known as guest access). The cost of this would be approximately £170+VAT and Cosmic would need to set it up, for which there would also be a cost implication. On the basis that the Town Council is negotiating with Mid Devon District Council to take over the ownership and management of the Council Office building and guest access to Wi-Fi will need to be available, it was resolved to replace the Council's current router with a VLAN device. (Proposed by Cllr Wyer) It was requested that the minutes show that Cllr Wright abstained from the vote as he had declared a personal interest as a CHAT Trustee.

- To consider a review of the Remembrance Sunday Parade and Commemorations and agree a course of action. The Clerk advised that she had recently met with representatives of the Royal British Legion, who wished to discuss how improvements could be made to the Remembrance Sunday Parade and Commemorations. The Clerk had agreed to contact all community groups and organisations to gain their feedback on the event for a Council committee to consider further. The Clerk suggested a site visit in September and a briefing session in October may also assist with any required improvements and help with the smooth running of the event. It was resolved for the Council's Administration & Personnel Committee to review the Remembrance Sunday Parade and Commemorations. (Proposed by Cllr Szabo)

Mr Scully asked the Group to hold in abeyance, for six months, its decision to disband, to allow him time to find volunteers to create a Friends of Newcombes Meadow Group.

Cllr Zorlu

- Has received several nice comments from residents regarding the work undertaken by Community Payback. This was echoed by Cllr Wyer.
- Whilst assisting Cllr Letch at the Mayor's Surgery she has received complaints regarding dog poo in the Town, particularly in the area of Barnfield play area. She has also witnessed dog owners throwing dog poo bags into hedges. She will be passing the details of offenders to the Clerk for further action.
- Recently she witnessed a parent smoking near children in the Newcombes Meadow play area and has asked the Clerk if anything can be done to stop this happening. The Clerk confirmed that her request had been forwarded to Mr Joe Scully, Operations Manager at Mid Devon District Council, who said nothing could be done as it is an open area. Cllr Wright confirmed that Mid Devon District





Council has discussed this issue previously and no action has been taken as stopping people smoking in the play areas cannot be enforced.

 will be carried out between the hours of 10.00 am and 3.30 pm.

- Recently an ambulance could not drive down Waresfoot Drive due to parked cars blocking the road. There has also been a problem with parked cars at Butt Parks and Spruce Park which have prevented the refuse lorries from turning.
- There is a continuing problem with hedges overhanging pavements. This causes problems for pedestrians and in particular parents with children and prams/pushchairs.


