36. To note concerns and recommendations to the Planning & Town Strategy Committee regarding works undertaken on the footpath at Four Mills Lane

- The Administrative Officer advised that the landowner will be installing stakes and tape as a temporary safety measure with a post and rail fence to be installed soon.
- Mrs Davies advised that DCC would not cover the cost of the post and rail fence.
- The Public Rights of Way Officers have no safety concerns as the path is an adequate width and path users should use their own judgement when using it.
- Cllr Cochran commented that the removal of trees is likely to be a breach of wildlife law.
- Cllr Downes suggested that the office write to the landowner to note the Town Council's dissatisfaction with the unlawful work.
- The Administrative Officer advised that the Town Clerk has been in correspondence with the administrators for the landowner and the local authority.



37. To receive an update on the Parish Path Scheme from Ros Davies, Devon County Council

- Mrs Davies advised no maintenance grant is currently needed as there are sufficient funds in the Town Council's budget.
- There is a free strimmer course due to take place in South Brent in June and July which is open to anyone interested.
- Cllr Cochran informed Mrs Davies about a fallen oak tree branch on footpath 6 and that it is currently blocking part of the kissing gate.

- 39. To receive the quotation for new signage to be added to footpath 5 at Downes golf club
 The Administrative Officer advised that she had received two quotations for the work.

 It was resolved to accept the first quotation of £192.00 from Ken White Signs (Proposed by Cllr Cochran).
