



## Minutes of Credition Town Council's Parish Paths Sub-Committee Meeting, held on Tuesday 25 October 2022, at 14.00, at The Bungalow, North Street, Credition

3. **To receive and accept apologies**

4. **Declarations of Interest**  
Cllr Downes and Cairney declared that as members of more than one authority, any views or opinions expressed at this meeting would be provisional and would not prejudice any views expressed at a meeting of another authority.
5. **Public Question Time**

  - Given the Pedlers Pool development, can we look at extending and improving path 24 and has the landowner been asked about this issue.
    - Cllr Brookes-Hocking agreed to speak to Laura Conygham regarding any previous conversation with the landowner.
  - Have we 106 monies from the Tarka View development that could be used in buying this field and planting trees etc as well as providing a much-needed multi-purpose path
    - Cllr Brookes-Hocking advised there is no Section 106 money available to improve footpath 24.

**9. To receive an update on the Parish Path Scheme from Ros Davies, Devon County Council**

The Administrative Officer reported that Ros had not been able to attend the meeting due to being on leave. She had updated her with the following information:

- The £350 allocated for resurfacing footpath 2 in 2020 was stalled, due to the landowner denying permission to access his land. The cost to transport the material along Tinpot was considered too high.
- P3 workshops were a success.
- Annual P3 survey forms will be circulated shortly.
- Budgets are completely spent and the financial forecast for next year is not great.

**10. Financial Report - To receive the financial report relating to Crediton parish paths**

The Administrative Officer advised there is just over £3,500 available in the budget.

**11. To discuss extending the handrail on footpath 29 to the bottom of the steps.**

Further information had been issued with the agenda. Councillors agreed for Cllr Cochran to visit the site to measure the length of handrail required.
