- 18. To receive and accept apologies. It was resolved to receive and accept apologies from Cllr N Letch (Proposed by Cllr Brookes-Hocking) The meeting was opened at 19.00.

19. Declarations of Interest

Cllr Downes declared that as a member of both the Crediton Town Council Planning and Town Strategy Committee and Mid Devon District Council (MDDC) Planning Committee, he reserves the right to change the way in which he votes in relation to any planning application on the basis that further information may become available. Furthermore, he will not declare to Crediton Town Council what any future voting intention will be when the matter is considered by Mid Devon District Council.

It was **resolved** to recommend objection, as there is concern an extension will obstruct light to the immediate neighbouring property. The streetscape of Peoples Park has been altered by the removal of the original boundary wall to create a parking space possibly without an application. It was suggested the wall be re-instated. (Proposed by Cllr Harris)

Proposal: Listed Building Consent for the change of use of offices to 2 self-contained flats Location: The Red House, St Lawrence Green, Crediton

It was **resolved** to recommend objection as there is insufficent parking in an area which is already overdeveloped. 27. To consider petitioning Devon County Council on the following items:

• Traffic control on A377 during emergency and scheduled road works

Cllr Brookes-Hocking advised that the Town Clerk had received a reply from Devon County Council (DCC) saying that utility companies and operators are asked to manually control the roads at peak times to avoid congestion but DCC cannot legally enforce them to do this. It was **resolved** for the committee clerk to write to DCC to thank them for the information but to stress the impact of traffic lights not working efficiently has on residents in the area and their journey times, and to reiterate this to the contractors operating them. (Proposed by Cllr Brookes-Hocking)

• Single white line cycle lane at Jockey Hill

It was **resolved** for the committee clerk to write to DCC to ask how in terms of promoting cycling can we ensure the cycle lane remains clear of parked vehicles. (Proposed by Cllr Brookes-Hocking) Cllr Downes agreed that the Town Council should support the enforcement regardless of the decision by DCC.

28. To receive an update on the Neighbourhood plan

Cllr Brookes-Hocking advised the plan is going to cabinet on the 12 July with a recommendation for accepting the modifications, and an agreement to go to referendum in early October. Cllr Downes wished to thank her for the effort she has put in over the past eight years getting the plan to this point.

29. To receive an update on Mid Devon District Council Community Led Housing

Cllr Brookes-Hocking advised that there is no update at this stage despite the Town Clerk and herself attempting to make contact with Mid Devon District Council (MDDC) but that she has
