- 168 To receive an update on Crediton Neighbourhood Plan and to consider a request for additional funding for consultant advice.** Cllr Brookes-Hocking explained that the Neighbourhood Plan consultants had reviewed the plan and made numerous recommendations. This had proved very worthwhile as one of the consultants is a Neighbourhood Plan Inspector. So far, the work had taken 4.5 days. Cllr Brookes-Hocking had requested an indication of how many more days consultative work is required in order to finish the project. They have estimated 6 more days are required. This would leave a shortfall of £600 in the Neighbourhood Plan Earmarked Reserve Fund. Cllr Brookes-Hocking also requested for the Council to make funds available for a further 4 days, if needed, which would be an additional £2,000. It was **resolved** to recommend to full Council that £2,600 is allocated from the General Fund to the Neighbourhood Plan Earmarked Reserve fund. (Proposed by Cllr Harris)
- 169 To consider a report, prepared by the Clerk, regarding the possibility of the Town Council acquiring the Devon County Council premises located at Old Landscore, Greenway, Crediton, EX17 3LP and agree any actions.** A copy of the report had been issued with the agenda and was considered by members. It was **resolved** for the Clerk to proceed with exploring the possibility of the Town Council acquiring the building, as per the recommendations in the report prepared by the Clerk, and to recommend to the Town Council that £5,000 is allocated from the General Fund towards researching the feasibility of the project. (Proposed by Cllr Letch)
- 170 To receive an update on the public consultations taking place on Wednesday, 6<sup>th</sup> March 2019, at the Boniface Centre and agree any last-minute actions.** The Clerk confirmed the presentation material was complete. Refreshments had been purchased with a £20 gift card supplied by Tesco. Enough tea and coffee had been purchased to cover the Annual Town Meeting on 27<sup>th</sup> March 2019 as well. Cllr Letch requested that the minutes record the Council's thanks to the office in getting the presentations together, in fairly difficult circumstances, in order for the Council to move the projects forward.
- Cllrs suggested that an A board and leaflets would be a good idea, however, it was noted this was too late to prepare.
- 171 To consider and agree how the Town Council can become more involved in influencing proposed footway and highway works within the town, especially in relation to proposed/new developments and in particular, Exeter Road/A377 in the light of the Tarka View development.** Cllr Brookes-Hocking gave an overview of a recent meeting she and the Town Clerk had attended with Mr Steve Short, Neighbourhood Highways Team at Devon County Council. During discussions Mr Short had offered for members of the Town Council to meet with him and Mr Ian Sorensen, Highways Development Management Officer (Mid Devon District) at Devon County Council, to

discuss how the Town Council and Highways could work together to influence proposed footway and highway works, in particular those proposed as a result of the Tarka View development. It was **resolved** for Cllrs Wyer and Brookes-Hocking to meet with Mr Sorensen and Mr Short. (Proposed by Cllr Harris)



It was **resolved** to support Sandford Parish Council's grant application to the Communities Together Fund. (Proposed by Cllr Wyer)

**173 To consider and comment on Devon Authorities Strategic Waste Committee's (DASWC) consultation on its review of the Reuse Credit Scheme (RCS).** Further information had been issued with the agenda and was discussed by members. It was **resolved** to note the consultation. (Proposed by Cllr Letch)
