79 To receive and accept apologies

84 Town Strategy Committee Minutes – To approve and sign the minutes of the Town Strategy Committee Meeting held on Tuesday, 3rd September 2019, as a correct record. 85 Matters Arising

There were no matters arising.

86 Mr Jon Tricker, from Phil Jones Associates, will be providing a presentation on the 'final conclusions' in relation to the development of a microsimulation Vissim model and the Credition Traffic & Urban Realm Feasibility Study. Cllr Wyer welcomed Mr Tricker to the meeting. Mr Tricker provided the presentation on the draft conclusions from the microsimulation Vissim model.

Mr Tricker explained that from a traffic capacity perspective the new scheme would work. The scheme provides better walkability, traffic speeds are lower, it's safer for pedestrians to cross the road and there are more opportunities to cross the road.

The overall results showed that in the morning peak journey times had been significantly improved by 17% – 29%. In the afternoon there had been a 6% increase in journey time but this is attributed to the reduction in speed of vehicles to 20 mph.

The scheme also shows an improvement in air quality in the vast majority of the High Street. The exception to this is East Town, where the model shows a negative air quality impact. This is believed to be due to the installation of a roundel as part of the placemaking. Therefore, this part of the scheme may need to be reconsidered and refined.

Following the presentation, Councillors had the opportunity to ask questions.

Mr Tricker advised that the next steps would be for him to discuss the findings with Officers at Mid Devon District Council and Devon County Council and to look at possible refinements to the East Town area. Following this, a report will be produced.

In the meantime, MDDC have been asking for cost estimates for different parts of the scheme and Mr Tricker has put them in touch with a Quantity Surveyor.

- It is over development of the site. Given the location of the proposed development, there is
 - no amenity space.
 - no private growing space.
 - the communal areas are inadequate.
 - the arrangement for recycling and refuse bins are ridiculous with a lack of space being provided.
- There is no adequate parking provision and the increased vehicles generated from the development will have an adverse impact on the already pressurised parking within the area.
- The application only provides 6 bicycle spaces, which is insufficient.
- There is no provision for prams/pushchairs.
- Some of the dwellings seem very small for current living standards.

89 To receive an update on Crediton Neighbourhood Plan. Cllr Brookes-Hocking provided the following update:

- The Plan is still at Regulation 14.
- Members of the Neighbourhood Plan Steering Group had met with representatives of QE School and Devon County Council (DCC), following DCC's request to remove Stonypark Field from being designated as open space. Following this meeting, the Neighbourhood Plan Steering Group had agreed to do this.
- Members had also met with Devon Communities Together to discuss its approach to undertaking a Housing Needs Assessment.
- The Neighbourhood Plan Consultants are still advising that the Crediton Neighbourhood Plan should follow the Local Plan, which now won't be completed until February/March 2020.

90 To receive an update from the Old Landscore School Sub-Committee regarding Old Landscore School, Greenway, Crediton, EX17 3LP and agree any actions. Clare advised that the building is now being used and feedback sought, which will feed into the feasibility study. Due to her holiday, there had been a delay in instructing contracts pertaining to the building and purchasing furniture and equipment. She was meeting with the Council's Special Projects and Services officer this week to discuss moving the project forward, this will include arranging meetings with Devon County Council Officers.

91. To receive an update from the Climate Change and Sustainability Sub-Committee and agree any actions. Cllr Brookes-Hocking confirmed that a meeting had been held on 24th September 2019, where she had accepted the position of Chairman of the Sub-Committee. Fifteen people had been present at the meeting. Members had reviewed and amended the Terms of Reference of the Sub-Committee in order to enable five councillors to serve on it. It had been agreed that two of the six community seats available on the Sub -Committee would be filled by one representative of Sustainable Crediton and one representative of Crediton Extinction Rebellion. The remaining four spaces will be filled as more interested parties come forward. An Ecological Emergency had been declared. The next meeting is scheduled for Tuesday, 12th November, subject to the availability of the meeting space. Meetings will be held monthly from January 2020 with the January meeting being a 'big meeting' to introduce the work of the Sub-Committee to the public. It is also intended to hold green fair workshops in the February half-term week.



92. **To receive an update on the Devon Air Ambulance Night Landing site and to appoint the contractors for the work and the funding of the project.** The Clerk explained that over the last few months the Council office staff had been liaising with Mr Toby Russell of the Devon Air Ambulance Trust (DAAT), representatives of Crediton Football Club and Mid Devon District Council, with a view to installing a night landing site at Crediton Football Club.

Cllr Brookes-Hocking left the meeting at 7.25 pm

The Clerk advised that the electrical work will be carried out by MAT Electric as they are DAAT's approved contractors for the night landing site electrical works. In addition to this there are numerous other works required at the football club in order to create adequate access, this includes the removal and pruning of some trees, groundworks and the installation of new gates. A great deal of time and effort has been invested by the Council's Special Projects and Services Officer in trying to obtain quotations for all these works. Whilst some contractors were able to provide a quotation for parts of the work, only one contractor had been able to provide a quotation for all of the works, this was R J Brooks.

The total cost of the works is £4,444.75 plus VAT. Of this DAAT will provide a grant to pay for labour costs and plant hire of £1,642.75. This leaves £2,802.00. The Town Council has already earmarked £1,000 to the project and Crediton Hospital League of Friends has confirmed that it will contribute up to £2,000 towards the project.

It was **resolved** as follows:

- to proceed with the project
- to instruct MAT Electric to carry out the electrical work
- to instruct R J Brooks to carry out the groundworks, tree works and installation of the gates.
- For the project to be funded from the Council's £1,000 earmarked reserve fund and grants received from DAAT and Crediton Hospital League of Friends.
