The Administrative Officer advised the following:

- Crediton Youth FC have not received formal written permission from Mid Devon District Council (MDDC) to site the containers, but they have been contacted via telephone and advised this could be done provided the structure is not permanent. The Administrative Officer has asked Crediton Youth FC for this information in writing.
It was **resolved** for the Administrative Officer to contact Crediton Youth FC again to enquire about the period that the containers are intended to be sited if formal permission is received (Proposed by Cllr Cochran).
- The Music Makers do not have any accounts to show as they have not been a constituted organisation prior to now.
It was **resolved** for the Administrative Officer to contact Music Makers to obtain a budget sheet, to enquire what the money would be used for and to advise if any support in kind is given from the Congregational Church (Proposed by Cllr Brookes-Hocking).

Agenda Item 6

Torrige, North, Mid and West Devon Citizens Advice **£3,000**

Vicki Rowe advised that Citizens Advice had suffered financially since the pandemic and had lost a significant number of volunteers (two thirds). Crediton is now benefitting from a face-to-face session once a week at the Foodbank with plans to increase to 2 days in the future subject to funding and successful recruitment of volunteers. Redlands GP surgery is being investigated as a potential location. Cllr Brookes-Hocking asked why the telephone service had been so poor in the last 2 years as members of the public have been reporting not getting through. She commented that this was due to a lack of volunteers to answer calls but that 60% of problems are resolved over the phone. A recruitment drive will be started but she estimated with training it would be 2 years before the service would be back to pre-Covid levels. It was agreed for Vicki to pass on details of the current session in Crediton and information on recruitment to the Administrative Officer for her to promote in town and on social media.

Vicki Rowe left the meeting at 13.51

It was **resolved** to approve the full amount of £3,000 to Torrige, North, Mid and West Devon Citizens Advice following ratification at a future meeting of the Full Council (Proposed by Cllr Harris)
