



Minutes of Credition Town Council's Planning & Town Strategy Committee held on Tuesday 01 November 2022 at 19.00 at Old Landscore School, Greenway, Credition

64. To receive and accept apologies. The meeting was opened at 19.00

It was **resolved** to receive and accept apologies from Cllrs Downes (personal), Huxtable and Ross (illness). (Proposed by Cllr Harris)

65. Declarations of Interest

Cllr Cairney declared that as a member of more than one authority, any views or opinions expressed at the meeting would be provisional and would not prejudice any views expressed at a meeting of another authority.

66. Public Question Time

A member of the public asked the following question:

- How can the new houses planned for Creedy Bridge use gas to heat and not be fitted with solar panels. I also do not see any cycle routes into Credition from the Creedy Bridge Site and why isn't the Creedy Bridge development under review when it is not yet been given full planning permission.
 - Cllr Brookes-Hocking advised the developer is only required to meet current building regulations and government guidelines for the quality of housing and how climate prepared it is. The government has not brought forward into legislation for better insulated and built homes and there is no requirement to exclude the use of fossil fuel energy or include solar panels. Developers will save money by leaving this to the purchaser. A letter was written to the local MP about the lack of appropriate legislation and a response was received, which can be provided on request.
 - The Town Council is advocating the best level route for cyclists, from Pedlers Pool into town and to improve connectivity into Old Tiverton Road. It is working with the Local Planning Authority to put pressure on the developers. The Town Council will be commenting on air quality and climate change in due course and looking at reserve matters including landscaping, scale, appearance and design/style, but not at vehicular access.

Mid Devon District Council (MDDC), the determining Authority, has asked for comments from this Town Council on the following planning applications:

Proposal: Reserved matter for the erection of 257 dwellings and up to 5 Gypsy and Traveller pitches; associated works in connection with 8.6ha of land to facilitate future CREDITON Rugby Club and up to 1.1ha of land for future primary school; details of landscaping, public open space and other associated infrastructure and engineering operations and access and highway work following outline approval 17/00348/MOUT
Location: Land at NGR 284185 101165 (Creedy Bridge) CREDITON, Devon

It was agreed to object to the application for the following reasons:

- Connectivity is inadequate. South east corner has no footpath
- Improvement of Stone Wall lane will encourage more traffic
- No consideration to cyclists
- Red roof tiles and brickwork not in keeping with the local area
- Poorly designed windows and doors
- Not adequately insulated and lack of solar panels

Cllr Brookes-Hocking suspended standing orders to allow a member of public to speak

It was commented that a potential closure of part of Peddlers Pool lane would make the estate quieter for cyclists and pedestrians.

Standing orders were reinstated.

It was **resolved** to recommend councillors come together to collate their precise detailed comments at a meeting on 22 November. (Proposed by Cllr Brookes-Hocking)

It was **resolved** to recommend objection to the change of use on the following grounds:



- Movement of vehicles at anti-social times is likely to cause disturbance to residents
 - Inappropriate location for a distribution business
 - No planting scheme for screening or biodiversity
 - Noise pollution
 - Lack of drainage
 - Lack of a site management plan and insufficient information about access



Cllr Brookes-Hocking said she would look into this before the Full Council meeting on 22 November.

The Town Council has met with parish and district councils to look at broad strategic issues such as connectivity, infrastructure and resources needed that will affect the future.
