



**Minutes of the of Credition Town Council Meeting held on

**2301/101 Public Question Time**

A member of the public asked if members would like to reflect on the decision to raise the precept given only three members voted in favour of the increase. They pointed out that several town councillors are co-opted and nobody has consulted with constituents. What mandate do councillors realistically feel they have to impose the 17% increase?

Cllr Brookes-Hocking advised that she cannot answer for members' feelings. Even if councillors are elected unopposed, they are elected, and any vote taken with a majority of one is a carried vote. There have been several consultations over the past few years, including a survey prior to Christmas regarding the value of services and if the precept should be increased. There was a 3-2 majority in agreement to increase the precept. She highlighted that she had held surgeries at the Farmers Market, and nobody had disagreed to an increase to protect services. All meetings are open to the public, council offices are open every day with the Town Clerk and staff always willing to answer questions. There are lots of opportunities for members of the public to partake in consultation. The town council feels it is necessary to keep Credition in good state, both physically and emotionally, and encourage community interaction. If the member of the public would like to discuss this further, it was suggested that they make an appointment with the Town Clerk.

Cllr Cairney stated that if the council doesn't provide services for young people, an increase in antisocial behaviour and vandalism is likely. Whilst he understands the comments made, it is integral to invest in people and the future and the town council cannot be shortsighted when setting the precept.
