2303/126 Public Question Time

2303/127 To receive and accept apologies

2303/133 To receive a report on the Sustainable Credition Hub and to approve any proposals forthcoming

Cllr Brookes-Hocking provided a brief overview of how some models of such hubs work in other towns. Sustainable Credition does not have its own space, with its larder housed at the library.

She had suggested that the hub could be housed in the front office for up to two years, which is currently vacant due to the council office relocation.

Consideration was given to the report written by Sustainable Crediton.

It was **resolved** that Crediton Town Council approves the proposal of a Hub in principle, with Cllr Brookes-Hocking and any other councillors who are interested, working with Sustainable Crediton to agree a plan that is suitable for both parties for future consideration and approval. (Proposed by Cllr Brookes-Hocking, Cllr Ross abstained).
