2303/110 Public Question Time

A question had been raised by a member of the public:

"Since 2016/2017 in percentage terms the Credition precept has risen as follows:-

2016/2017	21.5 %
2017/2018	12.0 %
2018/2019	11.4 %
2019/2020	00.0 %
2020/2021	5.0 %
2021/2022	25.0 %
2022/2023	13.8 %
2023/2024	17.2 %

Please explain why the total of these percentage increases, as far as I can see, exceeds those put in place by any other Town or Parish Council in England. Presumably you consider the increases put in place by other councils before decisions are made about any increases in our town?

Finally, are certain of our councillors totally out of touch with financial reality?"

Cllr Brookes-Hocking noted the concerns raised, but made the following points:

- All parish and town councils are in differing positions, such as whether they own income-generating assets or have a high rate of residential dwellings and therefore precepts may be subsidised
- Credition Town Council recognizes the cost-of-living impact on many people living in the town, but the wider benefits of the town councils service delivery is spread between all council tax payers
- Increases to the precept improves the town's resilience.

It was **resolved** to approve the request, with the location to receive final approval by the Town Clerk. (Proposed by Cllr Cochran). Cllr Brookes-Hocking thanked CISCO for the suggestion to undertake this project.

- 2303/122** **To receive and approve the quotation for the transfer of CCTV monitoring to Exeter City Council** (the quotation document had been issued with the agenda)
It was **resolved** to approve the quotation for the transfer. (Proposed by Cllr Harris).
- 2303/123** **To note the draft 2023/24 Meeting Calendar** (a copy of the calendar had been issued with the meeting)
It was **agreed** to swap Council Affairs and Full Council in May, but there were no other changes. The dates would be amended and recirculated.
- 2303/124** **To receive reports from Town Councillors** (for information only)
County Cllr Letch:
- Potholes – 28 teams fixing potholes, reducing to 14 in the summer. Potholes should be repaired no later than 28 days after being assessed if criteria is met. After repair, there is no quality inspection undertaken
 - Child Services - £127m overspend to be paid back by March 2026. There have been a lot of interim staff and turnover has been high. However, a Director and a Deputy Leader of Children Services are due to be appointed soon
 - Rail Forum – it was reported that over 60,000 journeys per month are being undertaken on the Tarka Line and a further 25,000 on the Dartmoor line.
- District Cllr Letch:
- Planning application at Newcombes – written to officers regarding concerns and requested a meeting if officer is minded to approve; a date for the meeting will be circulated.
- District Cllr Cairney:
- Leader of MDDC resigned and a new cabinet has been appointed
 - Newcombes Meadow paddling pool has been safeguarded for the next year
 - Pod homes project is not progressing as hoped, but in the next year the accommodation should be available.



District Cllr Downes:

- Car parking charge increase was stopped, an inflationary increase has been approved but long stay and overnight charges will not progress. Permits to park in St Saviours Way are available and equal 85p per day
- Wellparks planning application was removed from Planning Committee meeting last week.

Cllr F Letch:

- Expressed concerns regarding the steps from Cockles Rise to Dean Street.

Cllr Cochran:

- Liquidambar planted at Peoples Park.
