54. Public Question Time

The following points were made by members of the public in relation to planning application 21/02115/FULL Conversion of former doctors surgery to 4 childrens home dwellings (C2) with associated landscaping and parking

21/02113/FULL Conversion of former doctors surgery to 4 new dwellings with associated landscaping and parking:

- Introduction of young vulnerable children could increase anti-social behaviour and crime in local hot-spots
- Local senior residents feel concerned about the location and proximity of the childrens home to elderly people
- Inadequate planning by local authorities and insufficient information shared with local residents and objections not picked up
- Lack of resources, facilities and potential lack of supervision of children could result in problems within the town
- A member of the public commented that, should the premises become residential accomodation she would be more in favour of a childrens home than privately rented because she felt that a childrens home was a good idea and the community should support young people



- 61. To receive an update and consider any actions relating to work undertaken at Penton Lane by Devon County Council.** Further documentation was issued with the agenda. The Administrative Assistant confirmed that since receiving the correspondence from Devon County Council (DCC), two additional posts have been installed. This has increased the size of the posts as discussed at the site visit, but the width is still not sufficiently reduced to prevent a small vehicle passing through. A member of the public has requested that a lockable bollard or swing gate be installed, however, Devon County Council do not support this. The Town Clerk suggests this would set a dangerous precedent, a financial strain to maintain, may reduce accessibility of the footpath and unclear insurance responsibility. In the light of this information from DCC and the town clerk, it was agreed that no further action would be taken.
- 62. To receive an update on the Town Square if available**
The Administrative advised that The Town Clerk is waiting for an update from Mid Devon District Council (MDDC).



63. To receive a report on the Neighbourhood Plan

Cllr Brookes-Hocking advised that the Neighbourhood Plan had been submitted to the Local Planning Authority and that they are now responsible for publicising it. The public will have the opportunity to make comments with the consultation period ending of 14 January 2022. The Local Planning Authority will give the Town Council the opportunity to decide on an inspector who will examine the plan and decide if it should proceed to a referendum. In the future, MDDC will also propose a masterplan for Crediton but the two are separate plans. Cllr Cairney wished to thank Cllr Brookes-Hocking for her efforts in leading the Neighbourhood Plan.


64. To receive a report on the A377 Action Group and the Crediton Urban Realm and Traffic Study

Cllr Brookes-Hocking advised that she had attended a meeting with various local councillors and county representatives to address the concern about the volume of traffic coming down the A377 through smaller communities such as Newton St Cyres, and how this is negatively impacting them. Devon County Council potentially funding a feasibility study for a cycle route was discussed, with an update to follow next year. The Crediton Urban Realm Study and Traffic Study concept could be useful and transferable to the traffic issue increasingly affecting Newton St Cyres in particular. Cllr Brookes-Hocking added that she would keep the committee updated with any developments.
