1. To elect a Chairman for the year 2021-22

It was **resolved** to elect Cllr Brookes-Hocking as the Chairman for the year 2021-22. (Proposed by Cllr Harris).

It was **resolved** to elect Cllr Harris as the Deputy Chairman for the year 2021-22. (Proposed by Cllr Cairney).

Cllr Brookes-Hocking allowed members of the public to speak on planning application 21/00709/FULL.

The following points by members of the public were raised:

- Consideration be given as to whether Change of Use is of benefit to Crediton and the community
- This building is the only purpose built performance venue for live events available between Exeter and Torridge
- Irreplaceable building and asset to the town and has a long history as a cinema built in 1930s, which would be sad to lose for the community
- Valued by musicians, QE School, Exeter College and the Turning Tides Project and an excellent asset to encourage young people to perform
- List of 15 objections are yet to appear on Mid Devon District website
- Request for 6 months to be given for a community group to raise funds to purchase the building, by submitting an application to register the building as an Asset of Community Value.

Phil Cork from Crediton Dairy added the following:

- As a pub it has lost money over a period of 4 years
- Current facilities at the dairy are insufficient to accommodate business growth and this building adjoins the dairy
- There is potential to expand the business, which already employs over 150 people from the local area

- Employment land is difficult to obtain and these premises are available.

It was **resolved** to recommend that should the case officer be minded to approve the change of use, Cllr Downes be asked to call in the application to be heard by the MDDC Planning Committee. Cllr Brookes-Hocking explained that if this is the case, members of the public will also be able to speak about the application. It was agreed that the Change of Use application and the question of the Asset of Community Value listing should be an agenda item for Full Town Council on 8th June. (Proposed by Cllr Brookes-Hocking).
